

Ramsey County: Characteristics and Trends *Of Those Experiencing Homelessness in Minnesota*

Every three years, Wilder Research conducts a statewide study to better understand the prevalence, causes, circumstances, and effects of homelessness. The study includes face-to-face interviews throughout the state with people who meet the federal definition of homelessness, as well as a count of people who were homeless on a single night in late October. The most recent study was conducted on October 25, 2018.

This fact sheet highlights findings from interviews with people experiencing homelessness in Ramsey County. Wilder Research staff and trained volunteers conducted interviews in emergency shelters, domestic violence shelters, transitional housing, and non-shelter locations such as encampments, transit locations, hot-meal programs, and other drop-in service sites.

Homelessness in Ramsey County has increased over the previous two studies

- On October 25, 2018, there were **1,927** people experiencing homelessness in Ramsey County, up 8% from 1,787 counted in 2015. This increase follows a 14% increase in the number of homeless people counted in Ramsey County between 2012 and 2015.
- People experiencing homelessness in Ramsey County account for **19% of the state total** (10,233).
- The number of homeless children with their parents **increased 10%** from 2015 (541) to 2018 (593). Children and unaccompanied youth (age 24 or younger) represent 45% of the overall homeless population in Ramsey County (children 31% and unaccompanied youth 14%).
- 83% of homeless adults** (age 18+) in Ramsey County have been in Minnesota for more than two years.

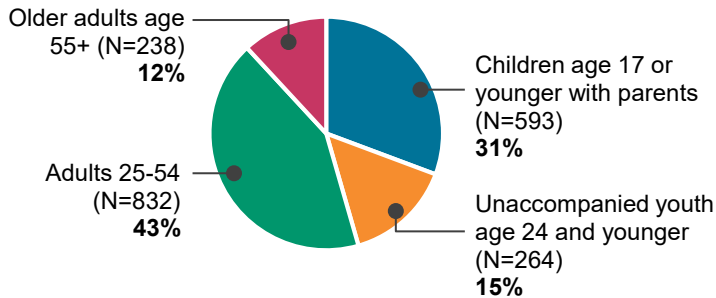
Changes in Ramsey County vary from year to year depending on age group

- Overall, there was a slight decrease between 2015 (902) and 2018 (857) in the number of children and youth (age 24 and younger) experiencing homelessness in Ramsey County; with the number of children with parents increasing (10%) and the number of unaccompanied youth decreasing (-27%).
- There was a marked increase in the number of adults age 25-54 (up 20%) and older adults (up 25%) experiencing homelessness in Ramsey County from 2015 to 2018.

In Ramsey County, nearly half of people experiencing homelessness are children and youth



The number of children, adults, and older adults have increased from 2012 to 2018; youth (21 and younger) numbers decreased over 2015 levels

- The number of homeless parents decrease over number found in 2015.
- The number of homeless older adults (age 55+) increased steadily from 2012 (165) to 2018 (236).
- The number of youth (age 21 and younger) decreased by 35% from 2015 to 2018, but was preceded by a 26% increase from 2012 to 2015.

Comparing numbers: Ramsey County and Hennepin County

It is helpful to look at homelessness as a regional issue, since the homeless population is highly mobile. Wilder's statewide data tables illustrate the difference between homeless numbers in the Twin Cities metro area versus greater Minnesota; however, this fact sheet looks more specifically at Hennepin compared to Ramsey County. Between 2015 and 2018, the number of people experiencing homelessness in Hennepin and Ramsey counties are up (11% in Hennepin; 8% in Ramsey). Some fluctuations in number of people between counties may be due to movement of homeless people as well as the ability of outreach workers to locate people who are staying outside of the shelter system. However, during the 2018 study, there was an increased visibility of unsheltered homelessness (and thus our ability to interview unsheltered people) due to a large encampment in Minneapolis (Hiawatha Avenue) and smaller encampments in St. Paul (Cathedral Hill).

Availability of affordable housing is still a critical issue in Ramsey County

- 46% of homeless adults (age 18+) are on a waiting list for subsidized housing, with an average wait time of 13 months; another 11% were unable to get on a waiting list because it was closed.
- 42% of youth (age 24 and younger) and 36% of adults (age 18+) spent at least one night sleeping outside in the 30-day period before the study.
- The most common reasons adults left their last housing: 40% could not afford it, 38% were evicted, and 31% lost their job or had their hours cut.
- Homeless adults had a median income of \$700 during the month of the study. At the time of the study, fair market rent determined annually by the federal government was \$864 per month for a one-bedroom apartment in the Twin Cities.
- 65% of homeless adults report that they would only need an efficiency or one-bedroom apartment.

Employment rates for people experiencing homelessness in Ramsey County continue to rise after reaching a low point in 2009

For youth age 24 or younger, 38% were employed at the time of the 2018 survey; 11% were working full time.

In Ramsey County, as in statewide, people who identify as African American, Native American or multi-racial are disproportionately affected by homelessness

More than 6 in 10 homeless adults in Ramsey County are experiencing long-term homelessness

For youth age 24 or younger, 2% were homeless for less than one month and 55% were homeless for one year or more. Sixty-three percent fit the MN definition of long-term homeless.

For youth age 24 or younger, 54% reported a serious mental illness, 37% reported a chronic physical health condition, and 12% reported a substance abuse disorder.

Seven percent of homeless adults in Ramsey County have served in the military; numbers are decreasing

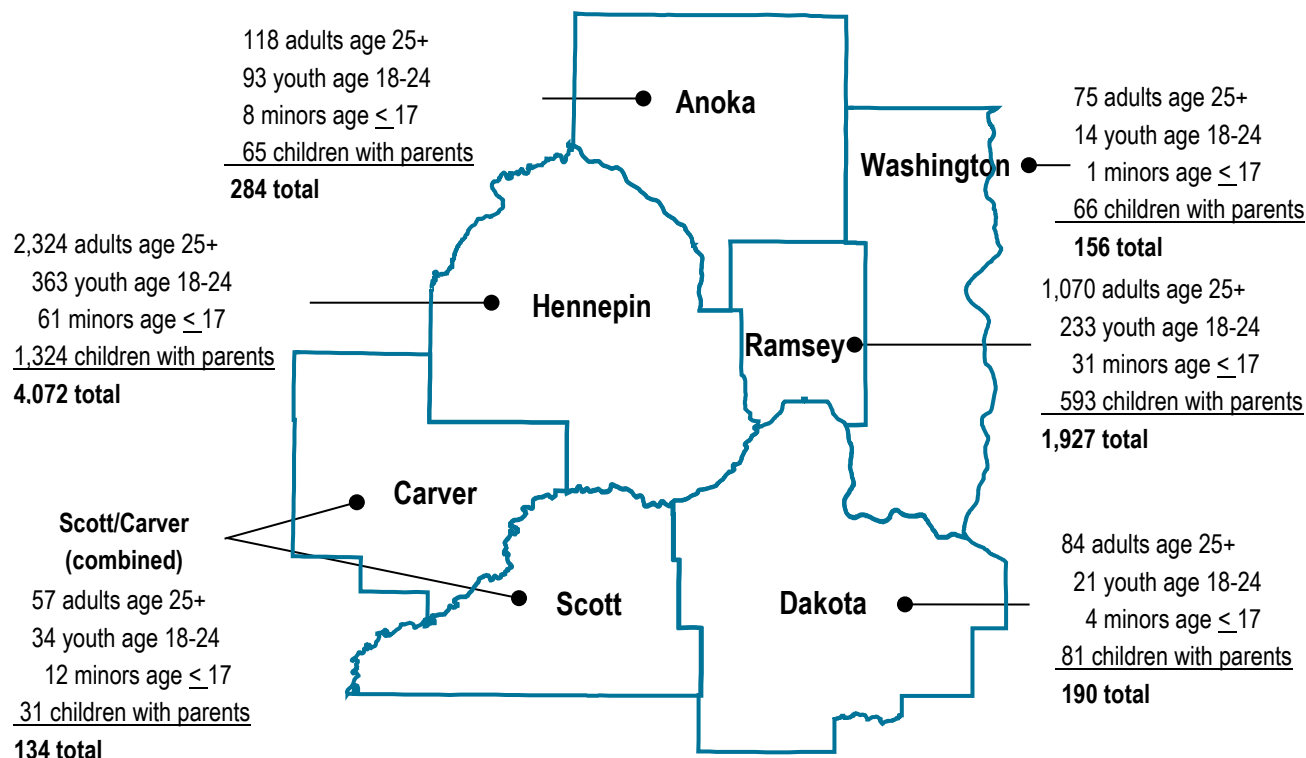
